



TERMS OF SERVICE

The following TERMS OF SERVICE (“Terms”, “Terms and Conditions”, “Terms of Use”) govern all use of Wiz of Ecom's Utopia website (<http://utopia.wizofecom.com/>) and all content and services and products available at or through the website. Wiz of Ecom's Utopia is a friendly place where like-minded people can share their knowledge of web entrepreneurship, e-commerce, Internet marketing and advertisements, and other similar business ventures. Please read these terms carefully before proceeding further to our website. By accessing or using any part of the web site, you agree to become bound by the terms and conditions of this agreement.
